RE: <u>Summary of June 19, 2020 Ex Parte Meeting Regarding Audio Links,</u> Docket No. 2020-5

Dear Ms. Smith and Ms. Chauvet,

On June 19, 2020, Susan Chertkof from the Recording Industry Association of America, Inc. ("RIAA") participated in an *ex parte* meeting with Regan Smith, Anna Chauvet, Jason Sloan, Terry Hart and Cassandra Sciortino of the Copyright Office concerning the above referenced matter. The meeting was also attended by representatives of the following organizations: MLC, DLC, the MLC Unclaimed Royalties Oversight Committee, NSAI, SONA, and MAC.¹ The purpose of this letter is to summarize the RIAA's contributions to the meeting.

The meeting focused on the MLC's request to have the DMPs include audio links for each listed sound recording in their monthly reports of usage and the DMPs' concerns about so doing. If provided, the links would not be included in the MLC's public-facing database, only in the claiming portal available to songwriters and music publishers.

RIAA participated in the meeting primarily as an interested observer. We did not express a position on the inclusion of audio links in the MLC's claiming portal. After

noting that we have not spoken with our members concerning the licensing issues raised by the DMPs, we expressed a concern that it would be inappropriate for the Copyright Office to issue regulations that would have the effect of mandating that certain terms be included in private marketplace deals between record companies and DMPs.

At the conclusion of the meeting, we indicated that we would speak with our members about the issues raised at the meeting and notify the Office regarding our position.
