## ITEM C. EXPLANATION OF NEED FOR RENEWAL

Provide a brief explanation summarizing the continuing need and justification for renewing the exemption. I am the Executive Director of New Media Rights.

New Media Rights has participated in the Digital Millennium Copyright Act triennial rulemaking process since 2008. We provide direct legal services to a wide variety of clients regarding copyright law, and specifically §1201. Our clients continue to directly experience the adverse effects of §1201 which has chilling effect on access to copyrighted works for otherwise legitimate purposes. This exemption helps to alleviate some of the statute's adverse effects. We have personal knowledge that there is a continuing need for the exemption, and that this need will remain strong in the next triennial period.

I and my staff personally know many filmmakers that have found it necessary to rely on this exemption during the current triennial period. I have recently spoken to filmmakers who intend to make these types of uses in the next triennial period.

In summary, if the exemption was not renewed, filmmakers would be unable to make noninfringing uses of the copyrighted works, and are likely to rely upon the exemption in the next three year period. There has also been no material change in the facts, law, or other circumstances set forth in the prior rulemaking record. There continues to be no reason that filmmakers should be denied access to copyrighted works when they make an otherwise lawful use of a copyrighted work. The individual examples and other evidence we provided in last triennial rulemaking process continue to support the need for the exemption, and encourage you to review that evidence.
