

## WHAT IS THE SCALED AGILE FRAMEWORK<sup>TM</sup> (SAFe)?

SAFe is a framework for applying agile methodology—which advocates business driven priorities, early delivery, continual improvement, and flexible responses to change—at an organization-wide level to holistically manage development.

Epics are the "big picture" or largest container of a project's scope.

Epics contain multiple features and user stories.

Features are pieces of functionality that fulfill a particular need.

User stories are portions of features written from the end-user perspective.



#### WHY SAFe?




- Advocates early delivery, collaboration, continual improvement, and flexible responses to change
- Facilitates organizationwide holistic management of large-scale application development efforts
- Focuses on cross-team communications, prioritization, and transparency

Forward thinking, planning, and coordination are major SAFe benefits!




#### **BENEFITS AND PROGRESS**


