Section to Cease Acceptance of PDF Submissions for Electronic Filing

Beginning with the 2023/2 accounting period, the Licensing Section will no longer accept PDF submissions of electronic statements of account. All electronic submissions must be submitted to <u>coplicsoa@</u> <u>copyright.gov</u> using the Excel form provided on the <u>section 111</u> <u>webpage</u>. Please note that Paper Submissions sent by mail will continue to be accepted.

Beginning with the 2023/1 accounting period, the Licensing Section no longer sends signed copies of e-SOA submissions to remitters. These statements will be made available on the **Licensing Section's website**, which is updated weekly as the section processes the statements. Copyright Office Issues a Supplemental Notice of Proposed Rulemaking Related to Termination Rights, Royalty Distributions, Ownership Transfers, Disputes, and the Music Modernization Act's Statutory Mechanical Blanket License

On September 26, the Copyright Office published a supplemental notice of proposed rulemaking modifying an earlier proposed rule regarding the applicability of the derivative works exception to termination rights under the Copyright Act to the statutory blanket mechanical license established under the Music Modernization Act. The supplemental notice also expands the proposed rule's scope to address matters relevant to identifying the proper payee to whom the mechanical licensing collective must distribute royalties. Copyright Office Issues Interpretive Rule Regarding Fees for Late Royalty Payments Under the Music Modernization Act's Blanket Mechanical License

On September 5, the Copyright Office issued an interpretive rule regarding the Music Modernization Act's due date for royalty payments as it relates to late fees under the blanket statutory mechanical license. In February 2023, following requests from interested parties, the Office published a notification of inquiry soliciting public comments regarding when royalty payments should be considered late, thus triggering late fees assessments. Interested parties were in disagreement about whether the Office's regulations governing the reporting by digital music providers under the Music Modernization Act's blanket license affected the Act's due date provisions.

Having carefully considered the statutory text, legislative history, and public comments, the Office concluded that the statute's due date provisions are unambiguous. The Office is not issuing regulations on this topic and is terminating its related notification of inquiry. More information can be found **here**.

Cost-of-Living Adjustment to Satellite Carrier Compulsory License Royalty Rates

On November 30, 2023, the Copyright Royalty Judges announced a cost-of-living adjustment (COLA) of 3.2 percent in the royalty rates satellite carriers pay for a compulsory license under the Copyright Act. The COLA is based on the change in the Consumer Price Index from October 2022 to October 2023. These rates are applicable to the period January 1, 2024, through December 31, 2024. Cost-of-Living Adjustment to Public Broadcasters Compulsory License Royalty Rate

On November 30, 2023, the Copyright Royalty Judges announced a cost-of-living adjustment (COLA) to the royalty rate that noncommercial radio stations at certain colleges, universities, and other educational institutions that are not affiliated with National Public Radio must pay for the use in 2024 of published nondramatic musical compositions in the SESAC Performing Rights, LLC (SESAC) and Global Music Rights, LLC (GMR) repertories pursuant to the statutory license under the Copyright Act for noncommercial broadcasting. These rates are applicable to the period January 1, 2024, through December 31, 2024. For more information, click **here**.

Cost-of-Living Adjustment to Royalty Rates for Webcaster Statutory License

On November 30, 2023, the Copyright Royalty Judges announce a cost-of-living adjustment (COLA) in the royalty rates that commercial and noncommercial noninteractive webcasters pay for eligible transmissions pursuant to the statutory licenses for the public performance of and for the making of ephemeral reproductions of sound recordings. These rates are applicable to the period January 1, 2024, through December 31, 2024. For more information, click **here**.

Cost of Living Adjustment for Royalty Rates and Terms for Making and Distributing Phonorecords

Effective January 1st, 2024, the Copyright Royalty Judges announced a cost of living adjustment (COLA) in the royalty rates for the statutory license for making and distributing phonorecords of nondramatic musical works regarding physical phonorecords and Permanent Downloads. Important Reminders for 2023/2

SATELLITE: The **\$725 filing fee** per statement in addition to the appropriate royalty fee is to be filed between **January 1 and January 30**, inclusive.*

CABLE: The **filing fee (\$15 for SA-1, \$20 for SA-2, or \$725 for SA-3) per statement** in addition to the appropriate royalty fee is to be filed between **January 1 and March 1**, inclusive.*

* Please remit the royalty fee and filing fee in one EFT payment.
