I understand there are those who love to do mashups and fanart and even put them on t-shirts cause the main companies dont do it like theyd sell a thundercat shirt from the 80s at disneyworld...somethings you just cant get them to make...and it is bad for them cause it is copyrighted stuff...uugh but still it is bad when someone tries to use mine without my permission and do not understand why people feel the need to copy someone elses works.. there is a canadian version of orphan works that is working pretty well and that i am all in favor of..there is no need to censor the internet just give more protection to those who post artworks by the date first....and for disney and other companies...to sell or hire people to create tees from the 80s that we so miss or just simply make a official licensing page for each character created by hollywood, disney, blue sky, pixar or anyone else in the movie media film media industry as well as gaming..purchase this character rights to use on any tshirt poster or product for so and so amount...but not let it be no higher than the product sells for..kind of like a pay per character type of thing.
