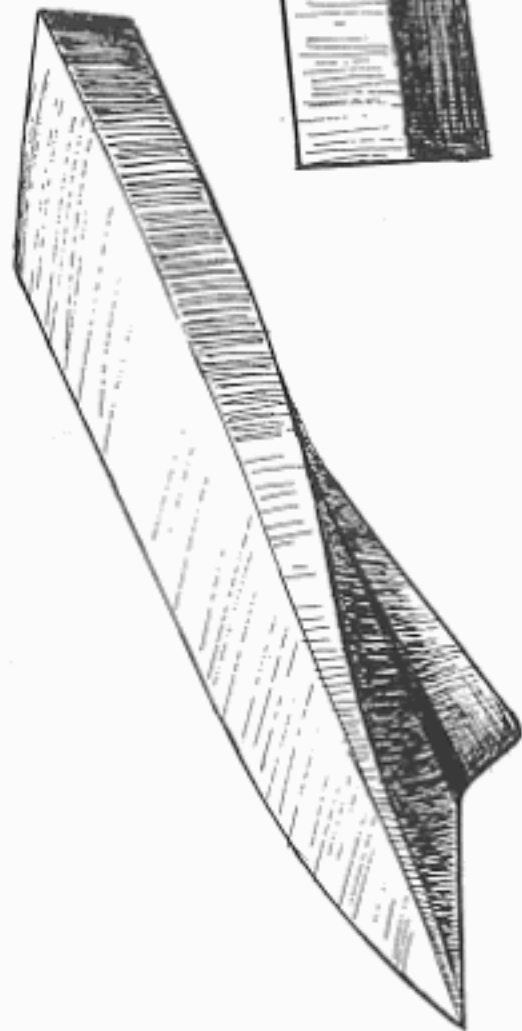
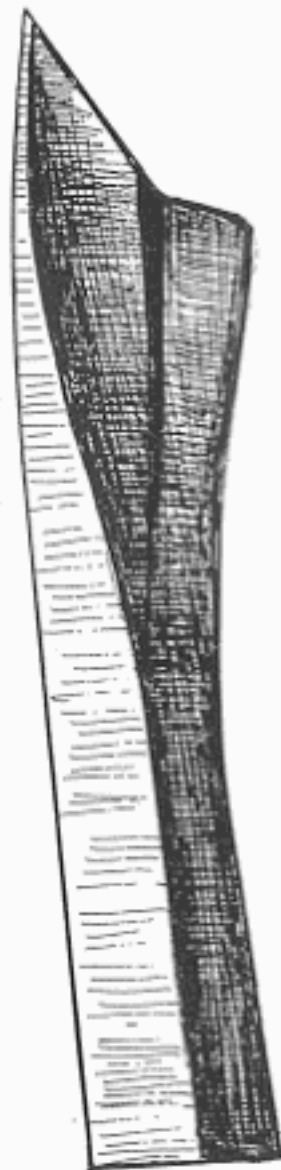


FIG. 1 FRONT VIEW

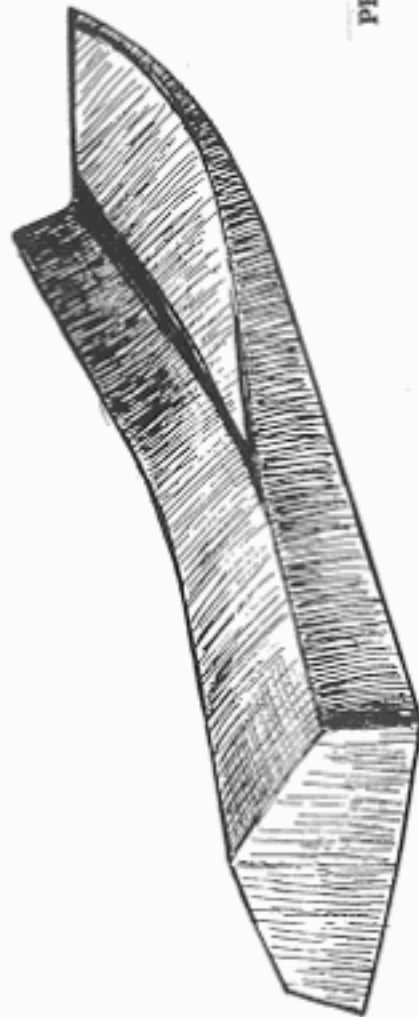


FIG. 2 PERSPECTIVE VIEW

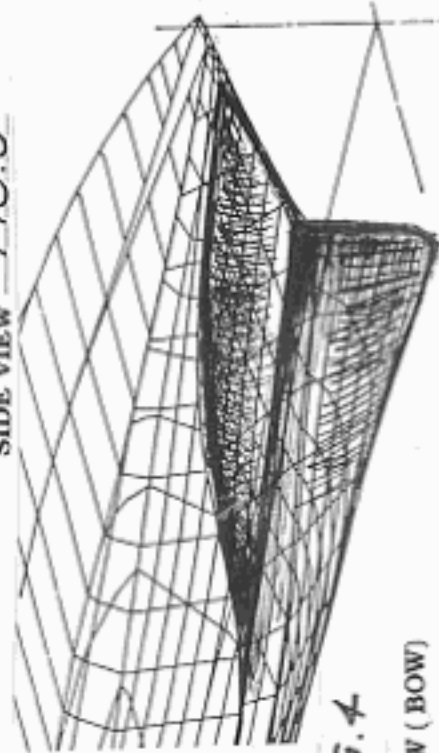

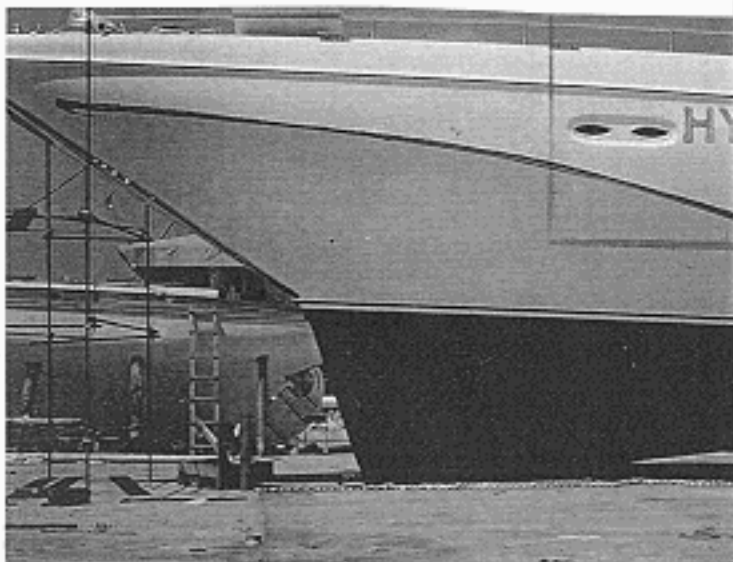

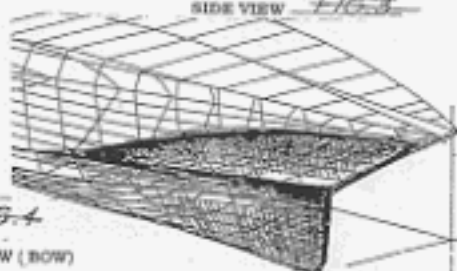


FIG. 4 PERSPECTIVE VIEW (BOW)
