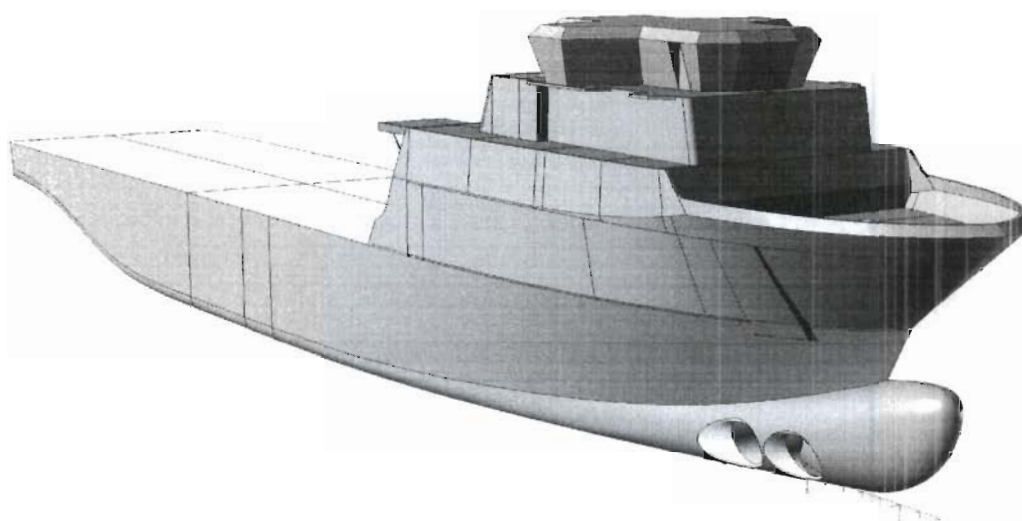

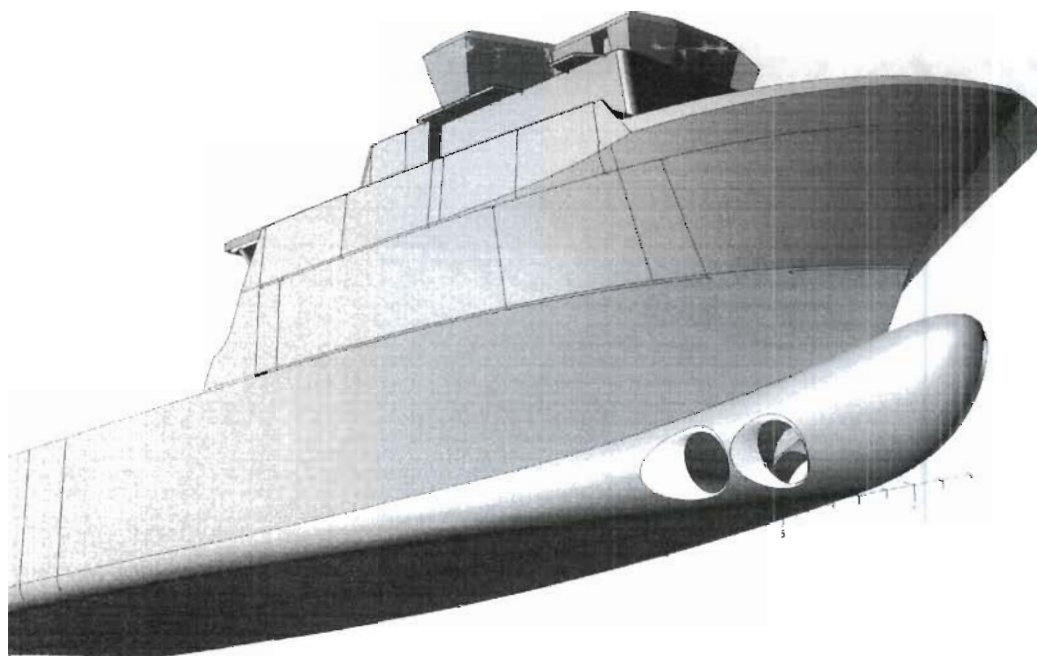

Outboard Profile in 3-D



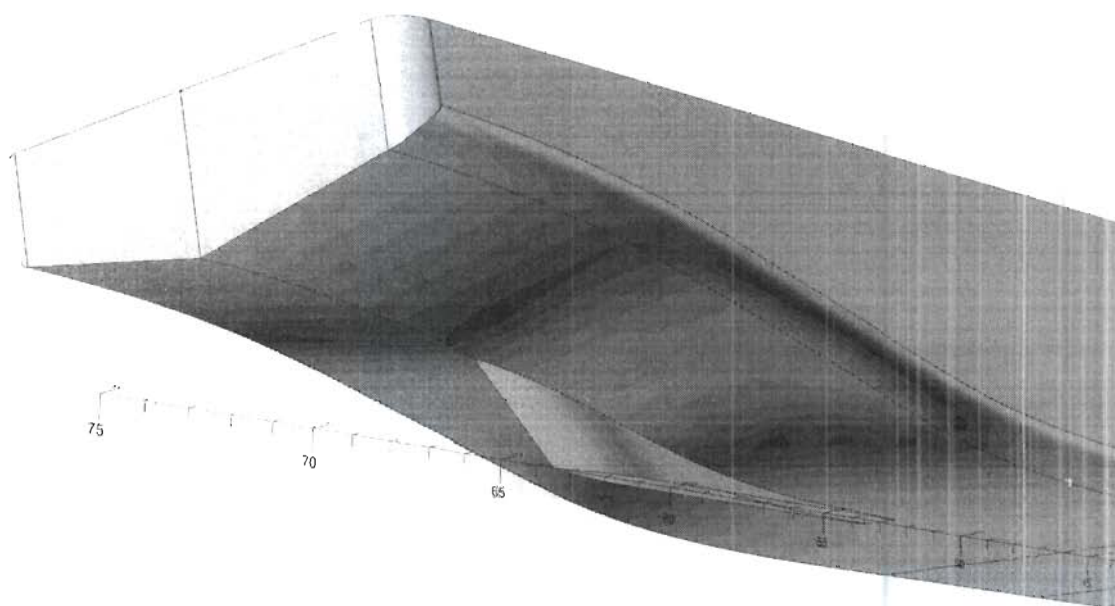
Bulbous Bow in 3-D
