SINGLE ENGINE INBOARD WITH JET. THIS IS A 6 CYLINDER DIESEL. HULL IS ROTATIONAL MOLDED WITH DEEP CHINE HAVING A TWISTING SHAPE WHILE MOVING FORWARD. PROVIDES FAST MOTION FOR GETTING UP ON STEP.

THE HULL MATERIAL IS A POLYETHYLENE CROSS-LINK WHICH IS LIGHTER THAN WATER RESISTS CRACKING OR BREAKING LIKE GLASS OR ALUM CONSTRUCTION. WHEN TURNED INTO A TIGHT TURN IN WIND BECOMES CHIEF THE CHINE & HULL PROFILE HOLD THAT TURN WHILE YOUR HANDS ARE NOT ON THE STEERING WHEEL.

THIS DESIGN WAS IN MY THOUGHTS BUT NEVER BUILT. I FORMERLY RAN BOATS BACK IN THE MID FIFTIES & EARLY SIXTIES. GLASS & GLASS HULLS BROKE UP AROUND WITH LESS POWER IN ROUGH WATER CONDITIONS.

THIS HULL HAS FLEX WITH A MOVED MEMORY.

SCOOPS BRING AIR IN TO THE ENGINE COMPARTMENT.

DOORS CLOSE 1/2 A WAVE WAVES OVER SCOOPS. AN
AIR CHAMBER UNDER SCOOPS CHANNELS WATER THROUGH
A HOSE BEHIND THE AIR BAG. AIR BAGS ARE MODULAR.

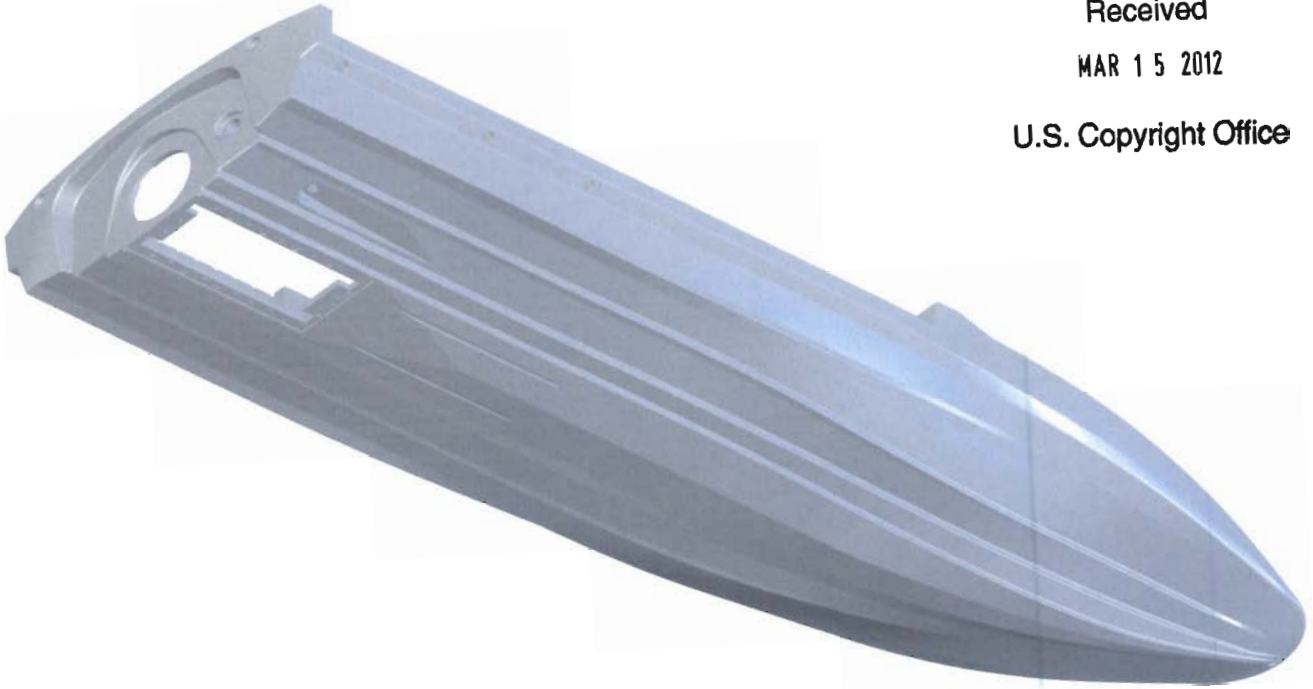

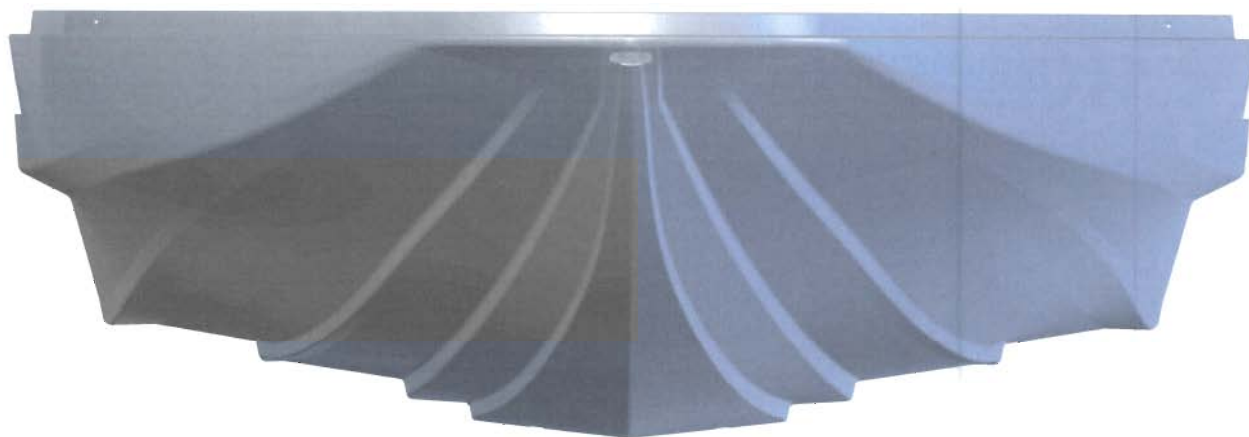
